- (1) The temporary recognition accorded to the school is valid 31.05.2021 and is to be renewed at an interval of every three years.
- (2) The grant of recognition is available initially for classes LKG to VIII Std and to be extended for Secondary / Senior Secondary Classes subsequently in due course
- (3) The School shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the Tamil Nadu Right of Children to Free and Compulsory Education Rules, 2011.
- (4) The School shall admit in pre-school / class I to the extent of 25% of the strength in each class, children belonging to Weaker Section and Disadvantaged Group in the neighborhood and provide free and compulsory elementary education till its completion.
- (5) The School shall maintain a separate bank account for the purpose of reimbursement.
- (6) The School shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
- (7) The School shall not deny admission to any child, -
 - (a) for lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
 - (b) on the ground of religion; caste or race, place of birth or any of them.
- (8) The School shall ensure that,
 - no child admitted shall be held back in any class or expelled from School till the completion of elementary education in a school;
 - no child shall be subjected to physical punishment or mental harassment.
 - no child is required to pass any board examination till the completion of elementary education;
 - every child completing elementary education shall be awarded a certificate as laid down under rule 21.
 - inclusion of students with disabilities / special needs as per provision of the
 - the teachers are recruited with minimum qualifications as laid under section 23(1) of the Act: Provided that the teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years;
 - the teacher performs his duties specified under sub-section (1) of section 24 of the Act; and
 - (viii) the teacher shall not engage himself for private teaching activities.
